New Business

- Incorporating Flagler County Intergroup has been achieved
- Ray G., Introduced a section of the By-laws for discussion. The portion that was brought up for discussion was, Section 1 Membership B. Only representatives or alternates of groups, on file with the FCI secretary may hold office, have say and vote in Intergroup. An AA group, for the purposes of inclusion in FCI, is a physical in-person or online meeting that adheres to the long form of tradition Three. Any meeting that limits or restricts attendance, e.g.: Men's meetings, Women's meetings, etc. shall not be eligible for representation at FCI." Tradition 3, in part, states that; "Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover..." It was brought up in the discussion that although a group might make an occasional exception to attend the meeting, IE. A women's meeting agrees to allow a male to attend a meeting the male would not be able to join that group. So, in the 3rd tradition, the exclusion is about membership, not attendance at the meeting. The Reps will bring this to their home groups on whether there should be a change to the By-Laws or should they remain as is. The reps should return with the results at next month's meeting. This does not affect the meeting list. The approved By-Laws are on the website www.AAflagler.Org/Intergroup
- Insurance will be obtained within the next week which will cover all our events
- A visitor had asked about insurance covering rides if Intergroup is providing information for people giving rides thru the Help Desk, Ray said he would look into that
- Discussion on dropping Zoom was made as there have been no participates in the last few months. It was decided to
 wait until the beginning of the year as we continue to invite groups to participate
